- Must be a current MIAAA member






MISSOURI N.I.A.A.A SCHOLARSHIP ESSAY WINNERS 2021

The two Missouri NIAAA Scholarship Essay winners for 2021 were seniors Andrew Lenzen from Northwest- Cedar Hill in Cedar Hill, Missouri and Ciarrah Bell from Marceline High School in Marceline, Missouri. Both student-athletes had outstanding essays and athletic credentials, as did many applicants. These student-athletes also had an outstanding record of civic duty. Their athletic directors spoke highly of their ability to give back to their community and of their devotion to other organizations within, and outside of, the school.

Ciarrah and Andrew will receive a \$1000.00 scholarship from the MIAAA and will present their essays at the MIAAA Spring Conference Banquet, which will be held April 11th, 2021 at Margaritaville Lake Resort in Osage Beach, MO. Their essays will go on to compete for an additional \$1500.00 scholarship at the NIAAA Section V meeting in Minneapolis, Minnesota on June 9th, 2021. 2021 MIAAA Certification Update

We have almost completed what has to be one of the toughest years of our career. The NIAAA has been offering a multitude of free workshops as well as quite a few LTC webinar classes. These classes can be the impetus for many to work on their current certification. Hopefully many of you have found time to take advantage of these opportunities.

There are five different levels of certification in the NIAAA. They are Registered Athletic Administrator (RAA), Registered International Athletic Administrator (RIAA), Registered Middle School Athletic Administrator (RMAA), Certified Athletic Administrator (CAA), and Certified Master Athletic Administrator (CMAA). There is a level for everyone. If you have questions about the different levels, clink on this link https:// members.niaaa.org/page/Certification, or visit the MI-AAAMO.org website where current information is posted as well. In order to become a CAA, athletic administrators must sit for an exam. The MIAAA is trying to make it easier for all to be able to sit for the exam. We are offering classes at the MSHSAA/MIAAA summer workshop, regionally we are offering classes in November, and of course, at the annual spring conference. The MIAAA also has increased the number of people qualified to proctor the CAA exam. The annual testing options for the CAA are the summer workshop at the national conference and the spring conference. If those dates do not work, athletic administrators can take it in the comfort of their home through Proctor U for an additional \$42.50. There is a charge to take the exam, but the MIAAA offers a scholarship for each of the eight districts yearly. If you would like to apply for this scholarship, touch base with your district representative.

The process to become a CMAA is also easier to do than in years past. In order to become a CMAA, a written project was needed. Now, athletic administrators have the option of doing an oral project via a video platform. The MIAAA would like to challenge all current CAAs to become CMAAs this year. We are looking to significantly increase the number of CMAAs. We currently only have nine active ADs in Missouri who have their CMAA designation. If you have any questions about this process, you can always reach out to myself, Josh Scott, or Doug Kuhlman. We are willing and able to assist anyone who wishes to start this process.

According to the NIAAA, certification with the NIAAA helps to develop a sense of personal and professional satisfaction. It demonstrates a commitment of excellence in the profession and allows for growth of professional knowledge and expertise. Being certified also increases the potential for employment opportunities or incentives. So, we are challenging the ADs of Missouri to reach a new certification level in 2020. Good luck!

STRATEGIC PLAN UPDATE

The MIAAA Strategic Plan Committee met via Zoom on April 27. The 5 year strategic plan (2018-2023) was put together as an important framework and guide to how we do business and grow as an organization. The committee discussed what has been accomplished, ongoing goals, and those parts of the plan that still need to be tackled. The Strategic Plan consists of three main areas/sub-committees – Finance, Operations and Programs. Within each of these areas goals and strategies for implementation were outlined. Below is a summary of where we are as we near the mid-point of our 5 year plan.

Finance: The Finance Committee's focus has been on fiscal soundness and responsibility as well as growing our membership. Our membership over the past two years has grown from approximately 385 to over 500. Linking our MIAAA/NIAAA membership with our MSHSAA registration has played a key part in this endeavor. The committee continues to evaluate membership and conference fees as well as looking at ways to maintain and grow our membership. An annual budget was created to help guide spending and prepare for each fiscal year. As we go forward over the next two and a half years leadership with focus on ways to increase our savings account to 50% of the annual spring conference expenses as well as research investment opportunities with a financial advisor for endowment growth.

Operations: The Operation Committee has focused on increasing membership, communication, technology, professional development, branding, creating an operations (POP) manual and election procedures. Again, we have had great success in increasing membership statewide (7-12) and this will continue to be a focus. The utilization of our website for best practices and highlighting our newsletters has also been accomplished. Expanding awareness and offerings of our professional development opportunities has also been a key endeavor. Presenting our PD information at the MASSP Conference and the creation of a one-page MIAAA information sheet have both been key in getting our information out to Athletic Administrators and other school leadership. Over the next two and a half years we will focus on branding, creating an organizational POP manual and more clearly defining our election procedures.

Programs: Finally, our Programs Committee has focused on Technology, Professional Development, Mentoring and recognizing Athletic Administrator's accomplishments. Our current offerings of LTI courses has been tweaked and restructured. These course offerings are now easily accessible on our MIAAA website and directly linked to the NIAAA website. Our Mentoring Program is one of the most successful in the United States and has been instrumental in assisting new Missouri AD's as they start their careers in athletic administration. Creating a New Athletic Administrator of the Year as well as Middle School Athletic Administrator of the Year have been focal points for the Programs Committee. The committee and our Mentoring Coordinator will continue to develop a statewide networking program as well as regional representatives for the Mentoring Program.


